ARTICLE I - NAME:

The name of this corporation shall be TNT Enterprises of Destin, Inc., (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION

The Corporation shall exist perpetually, commencing December 31, 2001, which is the date of subscription and acknowledgement of these Articles of Incorporation

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of transacting any and all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

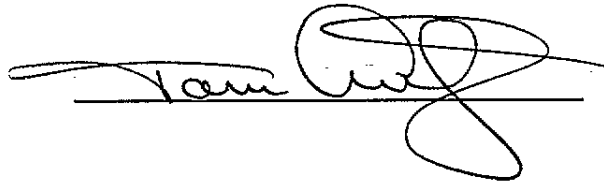
ARTICLE IX - BY-LAWS:

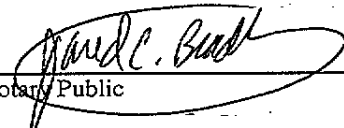
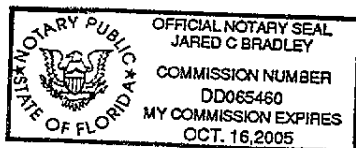

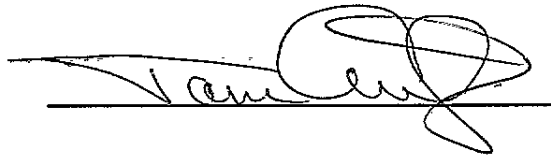
