ARTICLE I - NAME

The name of this corporation is A TO Z RENTALS, INC.

ARTICLE II - DURATION

This corporation shall exist into perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes: To purchase, rehabilitate, rent and sell real estate and for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to have 7500 shares of common stock at \$1.00 par value, which shall be designed "Common Shares" and is authorized to issue initially 500 shares at \$1.00 par value, which shall be fully paid for at the time of incorporation. Therefore, the initial capitalization of 500 shares shall be non-assessable.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - PRINCIPAL OFFICE

The principal office and mailing address of this corporation shall be located at 4738 Trouble Creek Road, New Port Richey, Florida, 34652, but the corporation shall have the power to relocate its principal office or to establish branch offices at other places as may be determined and deemed expedient.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 4738 Trouble Creek Road, New Port Richey, Florida, 34652, and the name of the initial registered agent of this corporation at that address is ARLYN L. PARTRIDGE.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by

the bylaws, but shall never be less than one. The name and address of the initial Directors of this corporation are:

ARTICLE XIII - CALLING OF SPECIAL MEETINGS

Special meetings of shareholders may be called by any stockholder owning not less than one-third of the shares.

Members of the Board of Directors may participate in general or special meetings of the Board of Directors by means of conference telephone as provided by law.

ARTICLE XV - DIVIDENDS

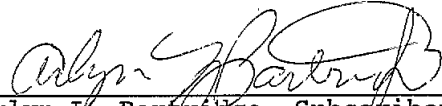
Dividends may be paid to shareholders, both out of the earned
