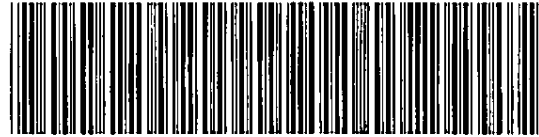



Article I. Name.


