# Articles of Incorporation of Atqui Corporation

The undersigned, files these Articles of Incorporation for the purpose of forming a Corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, privileges, rights and immunities of a corporation for profit, and does hereby organize the Corporation with the name set forth below and adopts the following Articles of Incorporation.

#### ARTICLE I: IDENTITY

The Corporation shall exist perpetually as Atqui Corporation ("Corporation").

#### ARTICLE II: PURPOSE

The purpose for which the corporation is organized is the transaction of any or all lawful business under the Florida General Corporation Act.

#### ARTICLE III: STOCK CERTIFICATES

The aggregate number of all classes of stock shall not be fixed and shall be modified from time to time by resolution of the board of directions, no par value. The Corporate certificates of shares must be signed by the president and vice president and sealed with the corporate seal.

#### ARTICLE IV: SHAREHOLDER RIGHTS

The shareholders shall have no preemptive rights whatsoever, and cumulative voting shall not be permitted.

#### ARTICLE V: CORPORATE OFFICE

The Corporation's principle office shall be located at 3400 North Riverside Drive, Indialantic, Florida 32903, and the Corporation's mailing address shall be located at P.O. BOX 780857, Orlando, Florida, 32878-0857. Various offices may exist for the Corporation, either within or outside Florida as the business of the corporation may require.

#### ARTICLE VI: REGISTERED AGENT

The name of the initial registered agent and the street address of the initial registered office of the Corporation shall be:

## ARTICLE VII: OFFICERS

The number of directors may be increased or decreased from time to time by amendment to the By-Laws of the Corporation; provided that the Corporation shall at all times have at least one director.

# ARTICLE VIII: FISCAL YEAR

The Corporation's fiscal year shall begin with the first day of January in each year.

### ARTICLE IX: AMMENDMENTS

The Corporation's directors shall have authority to alter, amend or repeal these articles, and shall have authority adopt new articles as the business of the Corporation requires.


