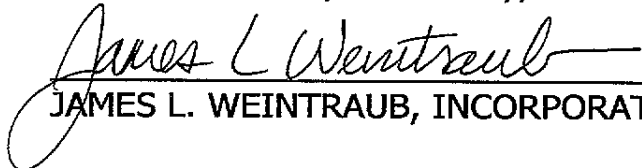
## **ARTICLE VII – INITIAL REGISTERED AGENT AND OFFICE**

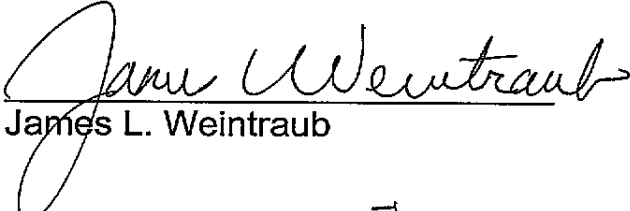
