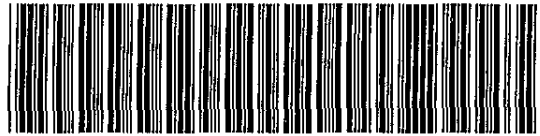

**ARTICLES OF AMENDMENT OF
NATIONAL HOMECRAFT OF BREVARD, INC.**

THE Articles of Incorporation of National Homecraft of Brevard, Inc., which were originally filed with the Secretary of State on January 14, 2002, are hereby amended to change the name of the Corporation as shown below:

Article I of the Articles of Incorporation of National Homecraft of Brevard, Inc. shall be amended as follows:

ARTICLE 1. NAME

The name of the corporation is Southern Home Technology, Inc.

The foregoing amendment was adopted and approved by a majority of the votes entitled to be cast on March 10, 2005, in the manner required by Section 607.1003, Florida Statutes, and by the Articles of Incorporation. The number of votes cast for the amendment was sufficient for approval.
