ARTICLES OF INCORPORATION

OF

TIDWELL POOL SERVICE, INC.

A Florida Corporation

ARTICLE I NAME

The name of the Corporation is: TIDWELL POOL SERVICE, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE
