1. The name of this Corporation is American Medical Network Association.
2. Article 3 of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE 3 - PRINCIPAL OFFICE

3. Article 5 of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

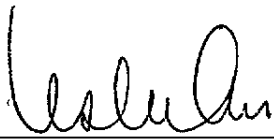
