**ARTICLE I. NAME**

The name of this corporation is **CLIPPED IN ARTISTS AMERICA, INC.**

**ARTICLE II. DURATION**

This corporation shall have perpetual existence commencing upon the filing of these Articles.

**ARTICLE III. PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV. CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of no par value common stock which shall be designated "Common Shares."
