



OF

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is Best Beer, Inc.
2. The principal office of the Corporation shall be located at 2240 Kidwin Lane, Lake Worth, Florida 33461.
3. The Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
4. The aggregate number of shares which the Corporation is authorized to issue is one thousand (1,000) shares of Common Stock, par value \$1.00 per share.
5. The street address of the initial registered office of this Corporation is 2240 Kidwin Lane, Lake Worth, Florida 33461 and the name of the initial registered agent of this Corporation at that address is Michael N. Fogel.
