ARTICLES OF INCORPORATION

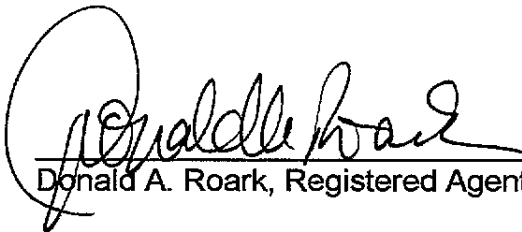
