ARTICLES OF INCORPORATION

ARTICLE 1 - NAME

The Name of the corporation shall be:

Lauren's Apts. Inc.

ARTICLE 2- DURATION

The corporation shall exist in perpetuity.

ARTICLE 3 - PURPOSE

ARTICLE 5 - PREEMPTIVE RIGHTS


