ARTICLES OF INCORPORATION OF DRUG SCREENING SERVICES, INC.

The undersigned, acting as incorporator of a corporation profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is DRUG SCREENING

SERVICES, INC. and the principal place of business shall be 2260

South Ferdon Boulevard #145, Crestview, FL 32536.

ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III.

PURPOSE: The purpose or purposes for which this corporation is organized is to engage in the business of drug screening and related services, and/or any activity or business permitted under the laws of the United States and the State of Florida.
