

**ARTICLES OF INCORPORATION
OF
DO-IT-YOURSELF SEPTIC SYSTEMS, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

Article I. Name

The name of the corporation shall be: DO-IT-YOURSELF SEPTIC SYSTEMS, INC. The principal place of business shall be 600 Bypass Drive, Suite #210, Clearwater, FL 33764.

Article II. Nature of Business

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the state of Florida, or any other state, country, territory or nation.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000,000 shares of voting common stock having a par value of .01 cent per share, and 1,000,000 shares of non-voting common stock having a par value of .01 cent per share.

Article IV. Address

The street address of the initial registered office of the corporation shall be 600 Bypass Drive, Suite #210, Clearwater, FL 33764; the name of the initial registered agent of the corporation at that address is Berkley C. Badger.

Article V. Term of Existence and Effective Date

This corporation is to exist perpetually. The effective date of incorporation is January 16, 2002.


Article VI. Preemptive Rights


Article VII. Directors
