AMENDMENT

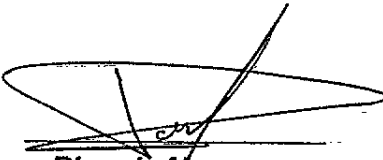
The right to amend or repeal any provisions contained in these Articles of

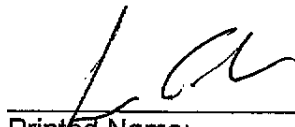
