ARTICLES OF DISSOLUTION

Pursuant to Section 607.1403, Florida Statutes, W.L. Jenkins Company, a Florida corporation (the "Corporation"), submits the following Articles of Dissolution:

ARTICLE I

The name of the corporation is W.L. Jenkins Company. The document number for the Corporation is P02000008102.

ARTICLE II

The voluntary dissolution of the Corporation was authorized on August 29, 2014.

ARTICLE III

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.

ARTICLE IV

These Articles of Dissolution shall become effective on December 31, 2014, except that if these Articles are not filed by the Department of State of the State of Florida on or before such date, corporate dissolution shall become effective upon filing by the Department of State, and the Corporation shall be dissolved as of such date.

NOTICE OF DISSOLUTION OF W.L. JENKINS COMPANY

This Notice of Dissolution is submitted by W.L. Jenkins Company, a Florida corporation (the "Corporation"), for resolution of payment of unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

ARTICLE I

The name of the Corporation is W.L. Jenkins Company.

ARTICLE II

The effective date of the voluntary dissolution, as specified in the Articles of Dissolution filed with the Florida Department of State, is December 31, 2014.

ARTICLE III
