To whom it may concern,

I filed for my P.A. Corporation in January of 2002 and received it in February 2002. I have not received any thing else since and I did not receive any file forms for 2002. A recent ordinance in my county now requires Real Estate agents to have individual Occupational License's. While waiting in line I was reading my through my license file and found the attached letter and became concerned that I hadn't received or filed anything.

I called my accountant immediately to check on this but since I did it on line myself prior to hiring her it would have been impossible anything was mailed to her.
