The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE – NAME OF CORPORATION

The name of the corporation is ChurchForce, Inc..

ARTICLE TWO – MAILING ADDRESS

The mailing address of ChurchForce, Inc. is 4920 Bay Crest Dr., Tampa, Florida 33615.

ARTICLE THREE – CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR –PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of providing the Christian business community with internet-based services designed to automate and facilitate online commerce and sales force management.
2. To establish profitable and beneficial ventures that will increase its market share, income streams, and/or value.

ARTICLE FIVE – CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10,000,000 shares. 5,000,000 shares shall be issued as common stock and shall have a par value of \$.001. 5,000,000 shares shall be issued as preferred stock and shall have a par value of \$.001. The board of directors shall have the exclusive right to designate and amend voting rights and dividend priority without shareholder approval.

ARTICLE SIX – REGISTERED OFFICE AND AGENT


