**AMENDMENT**



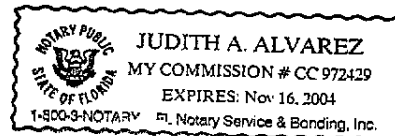


