The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the provisions of Chapter 607 Florida Statutes:

ARTICLE I - NAME

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 15,000 shares of Common Stock having a par value of \$1.00 per share.


**ARTICLE IV - INITIAL REGISTERED


