I, the undersigned being of legal age and a natural person, do hereby subscribe to and acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**

The name and initial address of this corporation shall be: Robert Golden & Associates, Inc., 104 Seashore Drive, Jupiter, Florida. 33477

**ARTICLE II**

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

**ARTICLE III**

The maximum number of shares of capital stock that this corporation is authorized to have outstanding at any one time is THREE THOUSAND -(3,000) shares of common stock, having a par value of (\$1.00) DOLLAR PER SHARE.

**ARTICLE IV**

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

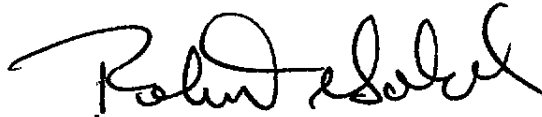
## **ARTICLE X**
