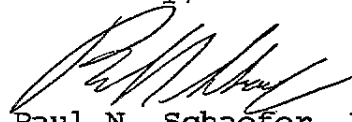

ARTICLES OF INCORPORATION  
OF  
BRIAN'S LAWN MAINTENANCE, INC.

ARTICLE I--NAME

The name of this corporation is BRIAN'S LAWN MAINTENANCE, INC.

ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III--PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV--CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V--PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase their pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI--INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 8411 Singapore Court, Orlando, Florida 32817, and the name of the initial registered agent of this corporation at that address is Brian Joseph Von Herbulis.

#### ARTICLE VII—INITIAL BOARD OF DIRECTORS

This corporation shall have two director(s) constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws, however, there shall never be less than one Director nor more than five. #### ARTICLE VIII—INCORPORATORS

#### ARTICLE IX—INDEMNIFICATION

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

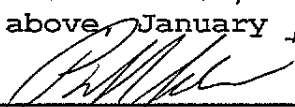

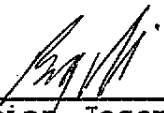
