ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the FLORIDA BUSINESS CORPORATION ACT, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME: The name of this corporation shall be: **PRESTIGE PROPERTY RENTALS, INC..**

ARTICLE II - PRINCIPAL OFFICE: The principal place of business and mailing address of this corporation shall be: 212-4 Cessna Blvd., Daytona Beach, Florida 32128.

ARTICLE III - SHARES: The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of No Par Value voting common stock which shall be designated "Voting Common Stock".
