

ARTICLE II

DURATION

the term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is the transaction for any and all lawful business for which corporations may be imporporated under the General Corporation Act of the State of Florida. These shall include but not be limited to, the power to suc and be sued, complain and defend in its corporate name in all actions and proceedings, and to have a Corporate Seal. The Corporation may also purchase, take, receive, lease, or otherwise acquire, cwn, hold, improve, use or otherwise deal in or with real or personal property or any interest therein wherever situated. It shall have the power to transact any lawful business which the Board of Directors shall find fine in aid of Government Policy. The Corporation shall further we the power to pay pensions and establish pension plans, and of merincentive plans for any and all its Directors, Officers and implifyees and for any and all of the Directors, Officers and Employees of its subsidiaries. It may be a promoter, incorporator, general partner, limited partner, member, associate or manager of any direction, partnership, limited partnership, joint venture, trust to parchase, take, receive, subscribe for, or otherwise acquire, own, wite use, cmploy, sell, mortgage, lend, pledge or otherwise dispersion and otherwise use and deal in and with shares or other interesting or obligations of other domestic and foreign corporation state ociations, partnerships and individuals including the d indirect obligations to the United States or any governmental body.
