

ARTICLES OF INCORPORATION

**M S R Technologies, Inc.**

The undersigned citizen, for the purpose of forming a Corporation, under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the Corporation shall be: **M S R Technologies, Inc.**
2. The principal place of business and mailing address of this Corporation shall be:

3. Subject to restrictions on the purchase, repurchase and transfer rights, as may be amended, in the by-laws, this Corporation shall authorize no more than One Million (1,000,000) shares of stock, to be outstanding at any one time, with a par value of One Cent (\$.01) each.
