Sir:

On 1/15/02 I filed the articles of incorporation for Cummings Design Solutions, Inc. On 5/13/02 I filed an amendment to these articles changing the address of the corporation. As this is the first corporation that I have started, I am new to many of the procedures and requirements governed by the state. It was recently brought to my attention that I was previously required to file a Profit Annual Report and pay a Supplemental Fee. I have also been made aware that since I have not filed my company has been given inactive status and that in order to reinstate the corporation I will be required to file the supplemental fee in addition to a \$1050 penalty fee.

I have not received any correspondence from the state regarding this fee or the status of my corporation. This leads me to believe that the state records were not updated when I filed my amendment to the original articles of incorporation changing the address of the company. In fact, the address listed on www.sunbiz.org is my old address even though the web site shows that I filed the amendment on 5/13/02.

Given the possibility that there was a mix up with my mailing address and the fact that I am a small corporation, new to the filing procedures, I would like to ask if the state would be willing to forgo the \$1050 penalty fee and reinstate my corporation to active status upon paying the \$150 supplemental fee.

I have enclosed a check for the \$150 fee.
