On 1/15/02 I filed the articles of incorporation for Cummings Design Solutions, Inc. On 5/13/02 I filed an amendment to these articles changing the address of the corporation. As this is the first corporation that I have started, I am new to many of the procedures and requirements governed by the state. It was recently brought to my attention that I was previously required to file a Profit Annual Report and pay a Supplemental Fee. I have also been made aware that since I have not filed my company has been given inactive status and that in order to reinstate the corporation I will be required to file the supplemental fee in addition to a \$1050 penalty fee.

I have not received any correspondence from the state regarding this fee or the status of my corporation. This leads me to believe that the state records were not updated when I filed my amendment to the original articles of incorporation changing the address of the company.
