THIS LETTER SERVES THE PURPOSE TO REQUEST FROM YOU THE OPPORTUNITY TO ACCEPT MY PAYMENT OF: ONE HUNDRED AND FIFTY DOLLARS NO CENTS, FOR THIS YEAR 2003 UNIFORM BUSINESS REPORT.
