ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation pursuant to chapter 607, Florida Statute, adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be JZSA BARBOSA CORP.

ARTICLE II

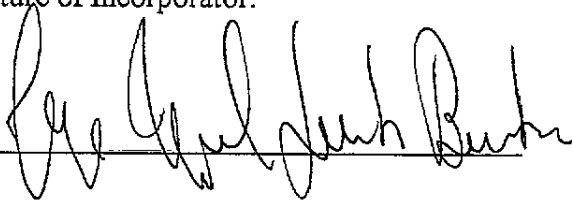
AMENDMENTS
