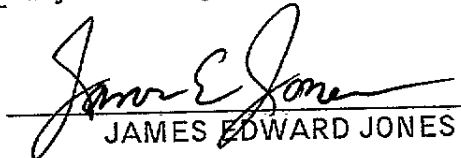
### ARTICLE IX - IDEMNIFICATION

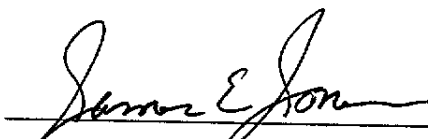

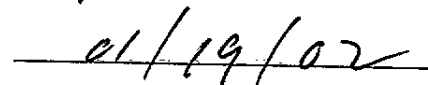

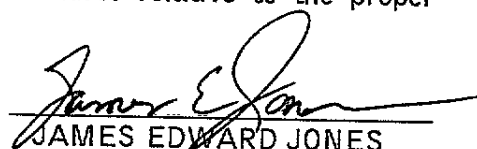
