I received a letter dated March 29, 2004 said that it is missing a registered agent. I sent the letter back with the registered agent information and signature in April 7, 2004. A few weeks later in May 2004, I call and inquired on the status since it is still inactive and make sure that they did receive the letter. They confirm me that they did receive the letter but due to the workload it might take more than five weeks. Several weeks later I call again but still get the same answer that it being process and they have a lot of work.

I am applying for the exemption of worker compensation as a corporate officer. However, I got denied due to the corporation is listing as inactive and it was not register with the Division of Corporation. I just check the status of DuQua, Inc. with Document # P02000009460 and it is still inactive.
