

I. NAME

The name of the corporation is FUN-N-THE SUN PLAYSYSTEMS, INC.

II. TERM OF EXISTENCE

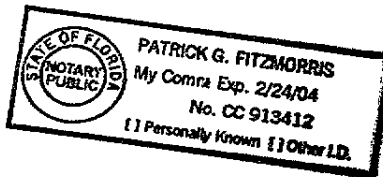


