




ARTICLE VII - Indemnification.

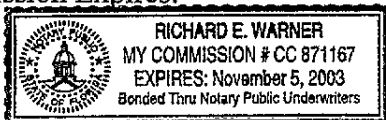
