

ARTICLE I - NAME

The name of this corporation is: SPRINGS GOLF PROPERTY, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized pursuant to Florida Statutes §607 for the purpose of holding and developing certain real property located in Broward County, Florida, and for no other purpose without a specific amendment to the Articles to the contrary.

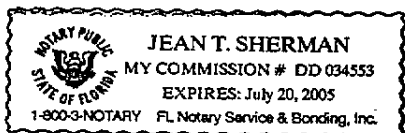


