

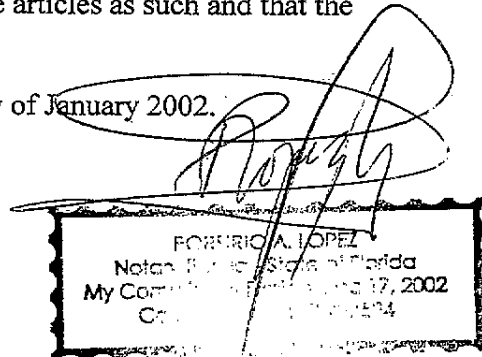

NAME OF THE CORPORATION


