The undersigned incorporators, for the purpose of forming a corporation under the Florida business corporation Act, hereby adopt the following articles of incorporation.

Article I - Name

The name of the corporation shall be Sunset Grocery & Retail, Inc.

Article II - Principal Office

The principal place of business and mailing address of this corporation shall be:

Article III - Purpose

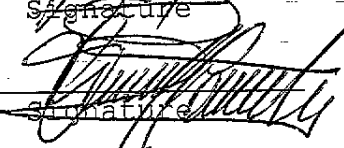
