The undersigned subscriber to these Articles of Incorporation, for the purpose of forming a ecoporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation is THE QUEST TRAINING CENTER & SPA, INC., a Florida corporation

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted is:

- To engage in every aspect and phase of the physical fitness business and to engage in every (a) aspect and phase of related businesses; and to engage in all other lawful businesses not prohibited by the Laws of Florida.
- To engage and render the professional services involved only through its officers, agents (b) and employees who shall be duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- To invest its funds in real estate, mortgages, stocks, bonds and any other type of (c) investments permitted by law.
- To engage in no other business other than the rendition of the professional services **(4)** specified herein.
- To do everything necessary and proper in accomplishing the purposes herein set forth and (e) to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

(f) The foregoing clauses shall be construed both as purposes and powers; and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of the corporation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be as fixed by the board of directors, and may take the form of services rendered, cash, property, or any other form deemed satisfactory by the board of directors.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V. ADDRESS

The street address of the principal and initial registered office of the corporation in the State of Florida is 3760 Commerce Center Drive, Sebring, Florida 33870. The board of directors may from time to time move the principal office to any other address in Florida, and may establish branch offices in such other place or places as may be designated by the board of directors.

ARTICLE VI. DIRECTORS

This corporation shall have two (2) directors, initially. The number of directors may be increased or diminished from time to time, by bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VII. DIRECTORS' POWERS
