ARTICLES OF INCORPORATION

FOR

ARTICLE I NAME

The name of the corporation shall be DSJJ Yogshwar, Inc.

ARTICLE II NATURE OF BUSINESS

The purpose of this corporation is to transact all lawful business.

ARTICLE III CAPITAL STOCK
