ARTICLE 1

NAME

The name of this Corporation is NETWORK PROFESSIONALS OF CENTRAL BROWARD, INC.

ARTICLE 2

PRINCIPAL PLACE OF BUSINESS

ARTICLE 3

ARTICLE 4

PURPOSES AND POWERS

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE 11
