Pursuant to the provisions of Section 607.1006, *Florida Statutes*, this Florida professional service corporation adopts the following amendment to its Articles of Incorporation:

Section 1 - Name and Background

JORGE R. ANGULO, D.D.S., P.A. is a professional service corporation organized and existing under the Florida Business Corporation Act, under document number P02000010045, filed in the office of the Department of State of the State of Florida on January 22, 2002 (hereinafter referred to as the "Corporation").
