ARTICLES OF INCORPORATION

OF

VAN PELT AND ASSOCIATES FHYSICAL THERAPY-OAKLAND PARK, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

VAN PELT AND ASSOCIATES PHYSICAL THERAPY-OAKLAND PARK, INC.

PRINCIPAL OFFICE

The mailing address of the initial principal office of this corporation is 1868 D, West Hillsboro Blvd., Deerfield Beach, FL 33442. The Board of Directors may, from time to time, change the street and post office address of the principal office of the corporation.

ARTICLE III PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be \$0.001 per share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.

Any conflict between the provisions hereof and thereof shall be controlled by the provisions of the Shareholder Agreement.

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, in the manner provided by law. The approval of each class of shareholders shall be required for any amendment or repeal.
