ARTICLES OF INCORPORATION
OF TOTAL CARGO CORPORATION

The undersigned acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

Article I

Name

The name of the corporation is Total Cargo Corporation.

The duration of the corporation will be perpetual.

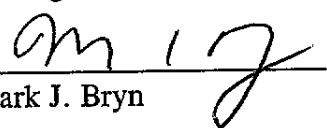
