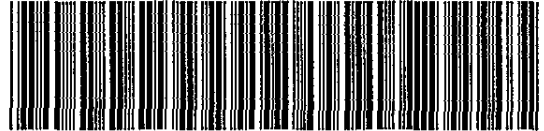



The name of the corporation is Aviation Export International, Inc.

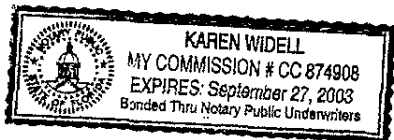


