The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

EFFECTIVE DATE

NAME AND ADDRESS

01-28-02

The name of the Corporation is Calusa Bob's Marine service, Inc. and the street address of the Corporation is 1687 Inlet Drive, North Ft. Myers, Florida 33903.

ARTICLE II

Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 10,000, all of which are to be voting common stock having a no par value.

ARTICLE IV

Registered Office and Registered Agent

Commencement of Existence

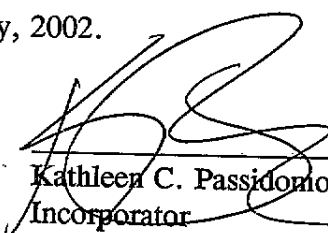
The Corporation shall be deemed to commence on the date of execution of Articles of Incorporation.
