ARTICLES OF INCORPORATION

OF

HARD EARNED CONSTRUCTION SERVICES, INC.

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby acts as an incorporator to form a corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is HARD EARNED CONSTRUCTION SERVICES, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on FEBRUARY 1, 2002.

ARTICLE III. PURPOSE
