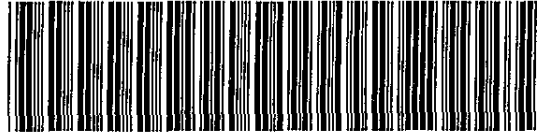

ARTICLES OF DISSOLUTION OF
CONCEPT DATA CORPORATION

Pursuant to the provisions of Sections 607.1402, 607.1403 and 607.0704 of the Florida Statutes, the undersigned, CONCEPT DATA CORPORATION, a Florida corporation (the "Corporation"), hereby adopts and submits the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is CONCEPT DATA CORPORATION.
2. The election to dissolve the Corporation, in accordance with Sections 607.1402, 607.1403, and 607.0704 of the Florida Business Corporation Act, was authorized by the unanimous written consent of the shareholders of the Corporation, on 9/17, 2002.
