The name of this corporation is:

HIGH PERCENTAGE INC.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The date when corporate existence shall commence is the date of the filing of the Articles of Incorporation by the Division of Corporations.

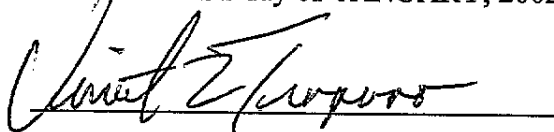

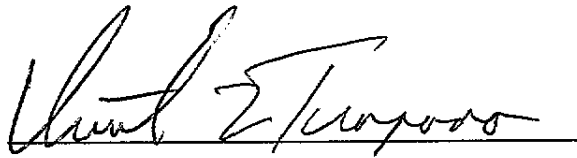
