ARTICLES OF INCORPORATION

OF

FLORIDA MOBILE MRI, INC.

<u>ARTICLE I - NAME</u>

The name of this corporation is FLORIDA MOBILE MRI, INC., and the mailing address shall be 4400 N. Federal Hwy, Suite 210 Boca Raton, Florida 33431.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE
