ARTICLES OF INCORPORATION

OF

OZ JANOS PARE! In compliance with the requirements of Chapter 607, Florida Statutes (2000 undersigned, being a natural person, hereby acts as an incorporator in adopting and filing following Articles of Incorporation for the purpose of organizing a business corporation.
