**ARTICLES OF INCORPORATION OF THE LAW
OFFICE OF CYNTHIA TOLBERT, ESQUIRE**

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME
